Court Time can be scheduled on the hour or on the half hour. If you select Court Time beginning in one Time Frame (listed below) and ending in another Time Frame, you must book two separate Court Times.

Example: If you want to book one hour of Court Time on Monday beginning at 8:30AM (Early Bird Time Frame), you must submit one booking for 1/2 Hour at 8:30 and select the corresponding Early Bird listing, then submit a second booking for 1/2 Hour at 9:00AM and select the corresponding Prime Time Frame.
